1. Who we are

This website is operated by Alitec Solutions Corp, 150 SE 2nd Ave, Miami 33131 ("Alitec," "we," "us"). This Privacy Policy explains what personal information we collect through this website and at NSA Trade Show 206, how we use it, and the choices you have.

2. Information we collect

Information you give us. When you register for your voucher at <https://alitect.antpk.co/register>, we collect your name, company, job title, email address, phone number, Miami / Florida, food industry.

Information collected automatically. Like most websites, our site and hosting provider may automatically record technical information such as your IP address, browser type, device, and the pages you visit.

We do not ask for sensitive personal information (such as Social Security numbers, financial account numbers, health information, or precise location). This website is intended for business users and is not directed to children. We do not knowingly collect information from anyone under 18.

3. How we use your information

1. To register you for the event and issue your voucher for 5% off your next purchase.
2. To verify and honor the voucher when you place an order.
3. To follow up with you about your interest in our machinery, stretch film, and service packages.
4. To send you marketing emails and promotions, if you choose to receive them (see Section 5).
5. To compile statistics about the event and improve our products and services.
6. To keep our website secure and to comply with legal obligations.

4. Your voucher and your information

The 5% voucher is offered to attendees who register. To issue it, we need your name, company, and email address. You are not required to agree to receive marketing in order to receive the voucher.

5. Marketing emails

If you agree, we may send you marketing emails about Alitec products, offers, and events. Every marketing email will identify us, include our postal address, and contain a clear way to unsubscribe. We will process unsubscribe requests within ten (10) business days. You will still receive transactional messages about your voucher or orders.

6. Phone calls and text messages

We will not send you marketing text messages or place automated or pre-recorded marketing calls unless you have given us separate, prior express written consent to do so. Your voucher does not depend on that consent.

7. How we share information

We share personal information only as follows:

- **Service providers** that help us run the website and the event, such as our web hosting provider (GoDaddy), and Outlook. They may use your information only to provide services to us.
- **Business partners**, such as Gruppo Fabbri, only where needed to fulfill your request or with your permission.
- **Legal and safety reasons**, when required by law or to protect our rights, customers, or others.
- **Business transfers**, if Alitec is involved in a merger, acquisition, or sale of assets.

We do not sell your personal information.

8. Where your information is stored

Your information is stored on servers located in [the United States]. If you access this website from outside the United States, your information will be transferred to and processed in the United States.

9. Data retention

We keep your information for as long as needed to provide the voucher and the other purposes described above, and in any event for no more than [12 months] after the event or after your voucher is redeemed or expires, unless a longer period is required by law. After that, we delete or anonymize it.

10. Security

We use reasonable administrative, technical, and physical safeguards to protect your information, including encrypted (HTTPS) connections. No system is completely secure. If a security breach affects your personal information, we will notify you and the appropriate authorities as required by applicable law, including the Florida Information Protection Act.

11. Your choices and rights

- Ask what personal information we hold about you.
- Correct or update your information.
- Ask us to delete your information.
- Opt out of marketing emails, texts, or calls.

We will respond to verified requests within 45 days. Residents of states with consumer privacy laws may have additional rights under those laws, and we will honor them where they apply to us. We will not treat you differently for exercising your privacy choices.

12. Changes to this policy

We may update this Privacy Policy from time to time. The "Effective date" above shows when it was last changed. If we make material changes, we will post the updated policy on this website.
